We are about 75% of the way flooded up.
- c) Colusa and Glenn Counties groundwater meetings The Manager passed out the documents from Lisa Hunter on the rate adjustment options. There were lots of discussions on designating types of water users.

7) DISTRICT OPERATIONS:

- a) Pumping plant (Electrical Control Building A/C) The Manager reported that we had to purchase a new AC unit for the pumping plant and they are also dealing with smoke detector issues.
- b) Current field activities The guys have been busy delivering water and getting on equipment when they can.
