a) Update on water conditions – The Manager reported that Shasta is just over 3.26 million acft. District diversions are tracking similar to last year. We have started to cut back.

b) Colusa and Glenn Counties groundwater meetings – Glenn County has had all of their public outreach meetings on the proposed fee structure and then had the public hearing last week on the rate structure changes. There were only about 250 letters of protest, about 2500 would have been needed to oppose, so the board passed the new fee structure.

6) DISTRICT OPERATIONS:

a) Pumping plant – The Manager reported that we are in a shut–off mode and lots of gates are going off. We will be scheduling the divers to come in for the meter replacements once things are off.

b) Current field activities – The Manager reported that we have also been spraying and cleaning canals. Ridge has been getting experience on the excavator. Alex fixed some crossing issues and has done some cleaning for a landowner at their expense.
